A WORD FROM PORTAGE

Throughout the past year, as Portage proved yet again its ability to adapt quickly and efficiently to the unprecedented demands and restrictions sparked by the pandemic, we also celebrated some important and uplifting milestones. First, our Anglophone Youth program, which relocated to the magnificent lac Écho site in the Laurentians region of Québec in 2014, celebrated its 20th anniversary in the winter of 2021. Since its inception, the program has helped nearly 1000 teens free themselves from addiction and prepare for a new and promising chapter of their life. Portage Atlantic also celebrated a special anniversary in 2021, marking 25 years of dedicated service to Atlantic youth aged 14 to 21 at the Cassidy Lake centre in New-Brunswick.

In addition to these milestones, Portage has made some exciting changes to its residential youth program in Saint-Malachie by extending it to young adults 18 to 21 in order to meet an increasing demand and the specific needs of that age group. The results of this new initiative have been so overwhelmingly positive that Portage is exploring the possibility of extending it to other adolescent programs. Portage's adult program at lac Écho has also seen some major improvements with the acquisition of a new pavilion that now houses its female community in an environment that is well-suited to the therapeutic community approach that is a hallmark of the organization's service offering.


Other projects we have been working on assiduously include implementing a Mother-Child program in Ontario and offering services specifically tailored to First Nations and Inuit populations.

In order to move ahead with its projects and maintain its ongoing service offering, Portage is currently conducting negotiations for public funding with the Ontario, New-Brunswick and Québec governments, whose support has been invaluable to our organization.

As we approach our 50th anniversary, there never has been a more urgent need for substance abuse treatment, as evidenced by the most recent data on opioid overdoses in Canada, a crisis that has been exacerbated by the COVID-19 pandemic. Given this increasingly difficult context, never has our commitment to providing high quality services based on best practices in the field of addiction treatment been as critically important. It is this commitment to excellence that allowed Portage to be accredited with exemplary standing in January 2022. This achievement was made possible by the extraordinary dedication and professionalism of our staff, the commitment of our partners and the courage and perseverance of our clients and their families.



PLANS FOR THE FUTURE

PORTAGE INAUGURATES A NEW WOMEN'S PAVILION AT LAC ÉCHO

Given the ageing facilities that until recently hosted the women's program at Lac Écho, Portage decided to invest in the acquisition and renovation of a new pavilion that would provide a setting conducive to recovery. The new facility is better adapted to the therapeutic community approach that lies at the heart of all Portage programs; by providing a shared space for women who are dealing with similar challenges, the new facility helps foster the community support that is an integral part of the program.

The new pavilion features numerous sports facilities that will benefit all residents of the Lac Écho rehabilitation centre. In addition to providing women enrolled in the adult program with more functional living spaces, the pavilion is equipped with an exterior basketball court and a tennis court that are open to residents from its other programs. These new sports facilities will benefit all residents and provide an added value to residents' stay, allowing them to connect more easily with other program members.



PORTAGE'S ANGLOPHONE YOUTH PROGRAM CELEBRATES 20 YEARS!

2021 marked the 20th anniversary of Portage's Anglophone Youth Program, which welcomed its first resident in January 2001. Since then, 988 Anglophone youth have attended the program with the goal of leading a healthy, productive life. "It all began in the Fall of 2000, when many meetings took place and we were offered a historic building in Beaconsfield, Quebec. Our top priority was to ensure an environment that was safe, comfortable and secure for the kids", explains Allan Farkas, Director of Admissions and Partnerships.

In 2014, the program was relocated to Portage's Lac Écho site, in the Laurentians, where young residents enjoy an ideal environment for their recovery.



NEW OUTREACH PROGRAM IN ONTARIO

In January 2022, Portage implemented a new outreach program for youth with substance abuse issues. A trained counsellor travels weekly or biweekly to different cities in Wellington County, Ontario to meet with youth. Group or individual meetings are planned according to the needs of each individual.

Portage visits youth centres, schools, and hospitals in the region to help young people dealing with substance abuse problems. In addition to helping youth in the field, this initiative raises awareness of Portage in the community.

TAILORING THE RESIDENTIAL YOUTH PROGRAM TO INDIVIDUAL NEEDS

The youth program has traditionally lasted a full six months during which participants acquire the tools they need to maintain a positive lifestyle once they leave Portage. In June 2022, Portage implemented a variable-length program that can last from three to six months, in order to better reflect its young clients' needs and life circumstances. This pilot project, which was first launched at the Lac Écho facility, will also be able to mitigate the expectations of both residents and their families regarding program length.

Last year, after carefully reviewing its own findings as well as its numerous discussions with partners in the health sector, Portage decided to extend its Saint-Malachie residential program offering to young adults aged 18 to 21.

SUSTAINABLE MOBILITY: ELECTRIC VEHICLES

In March 2022, Portage acquired its first hybrid vehicle for the Lac Écho rehabilitation centre located in Prévost, in the province of Québec. This marked the first stage of a much larger project to transition to a fleet of electric vehicles that will eventually meet all the organization's needs in terms of sustainable mobility.

Energy transition is a societal issue and should be an integral part of an organization's sustainable development strategies. Accordingly, Portage will seek to transition to a fully hybridfleet over the next 10 years in Québec, Ontario and New-Brunswick. In order to ensure the efficiency of its fleet, the organization will also set up charging stations at each of its centres and service points.

Portage recognizes the importance of making ecologically-sound choices and will focus on this project to ensure its transition towards sustainable mobility.

PORTAGE ORGANIZES AN INTERNATIONAL SYMPOSIUM WITH THE ICAA

Portage Atlantic, in partnership with the International Council on Alcohol and Addictions (ICAA), will be hosting a hybrid international symposium on women and addiction on September 22, 23 and 24, 2022 in Saint John, New Brunswick, Canada. The symposium will look at addiction treatment through the lens of the social determinants of health.



ACCREDITATION

CANADA

99.6% OF CRITERIA FULFILLED

Accreditation Canada, a national organisation that supports and assesses good practices in health and social services establishments, conducted an on-site survey of Portage's centres and administrative offices in late October 2021. We are proud to announce that subsequent to the survey, **Portage was accredited with exemplary standing!**



ONGOING QUALITY IMPROVEMENT

The accreditation process is based on the ongoing improvement of services in terms of both quality and safety. Portage was first accredited in the early 2000s' and has since renewed its accreditation every four years. The assessment is based on an examination of facilities, a documentary review, an evaluation of the organisation's policies and procedures, testimonials by clients and families, the well-being of staff and cooperation with the organisation's partners.



At this year's on-site survey, Portage distinguished itself by meeting 99.6 % of 555 assessment criteria and demonstrating compliance with all required organisational practices: "The organisation attained the highest possible level of results and has demonstrated excellence in its compliance with the accreditation program requirements." Several specific features drew the attention of the Accreditation Canada survey team, including the importance Portage affords to its partnership with clients and their families, a feature our organisation is very proud of: "Portage developed its services on the therapeutic community model involving a partnership between the patient (client) and their family for each of the steps in their flow and the development of their skills. This model is specific to Portage and is constantly evolving with the development of new evidence-based practices, while consolidating the clinical expertise of health care professionals."

The Accreditation Canada team representatives participated in the 5-day evaluation of 9 sites. They also unanimously highlighted the quality of the organisation's management and the involvement of its numerous partners: "(...) support from senior management, the Board of Director's standing committees, as well as their leadership committed to patient and client safety are components that contribute to methodical and rigorous activities based on Portage's intervention philosophy."

The team also highlighted Portage's ability to adapt in spite of the challenges caused by the pandemic and to maintain its service offering while continuing to improve many of its practices. As stated in Accreditation Canada's report, "the organisation was able to maintain its service offering, while meeting the safety standards required by the public health departments of the provinces served. In this regard, we should point out the work by the employees and management who quickly reorganized the service offering, while ensuring client safety."

Portage is extremely proud to have been accredited with exemplary standing. This achievement was made possible by the dedication and professionalism of its staff, the commitment of its partners and the courage and perseverance of its clients and their families. It is thanks to them that Portage has maintained and improved the quality of its services for nearly 50 years.

TESTIMONIAL

It takes a long time for a parent to realize their child has a substance use problem. After all, maybe their behaviour is just part of being a teenager. Maybe it's just a phase.

I had started noticing changes in my son's behaviour. He had a new group of friends. I was getting calls from the school principal. My son became withdrawn. He'd come home and go straight to his room. It took me a while to recognize the signs of substance abuse.

After I picked up the phone and made the call, everything went quickly: they called back the very

next day and scheduled an appointment three days later. Then comes the crucial moment when your child has to agree to go into treatment. At that point, the only thing you want is for him to go to Portage. All you can think is: if you don't take him, I don't know what I'll do; I'm desperate. I had the good fortune of speaking with Kim, who was a huge help to us. She understood my son right away. That was a crucial moment because if Portage hadn't been there, I don't know what I would've done. The word despair takes on its full meaning when you can't help your child while knowing he's at risk of becoming an addict and a homeless person for the rest of his life, unless he changes.

My son needed help, but so did I. The first part of getting that help was knowing someone was giving my son the care he needed. It was such a relief. The first few weeks, it's great; you can finally get some sleep, you stop wondering where your child is at night, you trust he'll get better because you know he's in good hands. For my son, those first weeks were really hard. He just wanted to leave the program. He told me he wasn't like the other people there; he wasn't as badly off as them, he didn't fit in with those "crazy people". It took him at least three months to realize the full extent of his substance use problem and to understand he had to get to the root of his problem.

In addition to providing my son with the support and tools he needed, Portage got to the root causes of his substance use. Uncovering those root causes was essential to rebuilding the person he had once been. Taking an in-depth look at a person's emotional problems is what makes the therapy work, and it's what makes people thoroughly commit to the therapy. One of Portage's strengths is how they support parents. I thought I would have to look for help outside Portage, but they offer complete family support services. I attended all the family support meetings and they changed my life. Even now that my son has completed his therapy, I go once a month and I get so much out of it.

You're part of a community of parents that is built on mutual support. The first thing you realize is you don't feel alone as a parent anymore, and that makes a world of difference. You're also given the right tools and coached on becoming an integral part of your child's therapy. Your child has his therapy and you have yours. There's a tendency to put a lot of blame on the child, but whether we like it or not, parents are part of the reason behind a child's substance use. Certain decisions a parent makes in a child's life have a much bigger impact that one would think. It's important to accept that, to listen and to remain open-minded. Once you understand that, you can move forward.

It's really hard to do, but once you're fully committed, you can start moving forward. As parents, we have to acknowledge our mistakes in order to rebuild our relationship with our child. Trust is something you build together. I came to understand it wasn't just my son's therapy, it was our therapy. Because that child comes back home after his program. And everything isn't perfect; it's not about sweeping everything under the rug as if nothing had ever happened. That's not it at all. Towards the end of the residential program, we had to make sure we maintained really strong, honest channels of communication.

Portage is all that. It's the before, the during and the after. It's a therapy for youth dealing with substance use issues, but it's also therapy that supports families and does so very well. Recently, I had doubts about certain things and I decided to talk about them with my social reintegration counsellor. He answered my call immediately. Post-therapy support is extremely important. The parents' group still holds meetings and, if I want to, I can join in any week, even if I haven't attended in over a month. I'm always welcome.

The meetings are also a way of passing on what I've learned to other parents who are just starting therapy. Parents who have gone through Portage form very strong bonds.

Portage has helped make me the person I am now. It goes beyond the services they provide. You can just tell that the work the counsellors do is their vocation, and that applies to each and every one of them. And that makes a huge difference. I certainly felt it.

SOIRÉE DES GRANDS PHILANTHROPES

The 18th edition of the Soirée des Grands Philanthropes took place on Thursday September 23, 2021. The Foundation reinvented the format of the prestigious event again this year, adding a hybrid component.

The Soirée paid tribute to Alain Lemaire, Co-Founder and Executive Chairman of the Board of Cascades, and Robert Tessier, Chairman of the Board of the Caisse de dépôt et placement du Québec (CDPQ), who attended the event in person at the Fairmont Le Reine Elizabeth along with the members of the honorary committee and guest artists. They were able to share the official part of the evening via live broadcast with 700 participants who savoured their gourmet meal from the comfort of their home.

The event raised a net amount of \$1,250,000, including \$51,550 from the online auction, thanks to the great generosity of participants from the Montréal and Québec City areas who answered Portage's invitation.

We would like to thank the co-chairs of the evening, Charles Emond, Julie Godin, Karine Moses and Louis Vachon, as well as the members of the honorary committee.

In addition, a promotional video on Portage's programs was officially launched during the event, garnering positive reviews from all the participants for its relevance and quality. Guests were especially moved by the testimonial of a recent graduate of the youth residential program who, after describing his journey through Portage, expressed his gratitude towards the counsellors and therapeutic community who supported and guided him towards a promising future.







MONTRÉAL GOLF OPEN

On a sunny June 7, 2021, 148 golfers attended the 23rd edition of the Golf Open held at the prestigious Laval-sur-le-Lac golf club. The event was a great success, generating a net total of \$144,000.

The event owes its success to the communicative enthusiasm of Stéphane Dufort, honorary chair of the golf open, and to the determination of the organizing committee, who together met the challenge of raising this sum despite the pandemic.

The event proceeded in strict compliance with all public health directives. The funds that were raised went to Portage's mission of providing services to vulnerable youth.



QUÉBEC GOLF OPEN

On June 14, 2021, a torrential downpour forced the cancellation of the 26th edition of the Québec City Golf Open that was to take place at the prestigious Club de Golf Royal Québec. As compensation, every company that had booked a foursome was allotted four green fees to be used on the day of their choosing.

Despite the cancellation, a total of \$94,000 was raised, thanks to the hard work of the organizing committee, headed by Martin Vézina, Vice-President of Sales at PPI. This was truly a remarkable and unprecedented achievement and we would like to extend our heartfelt thanks to them all.

Because of the cancellation, the breakfasts ordered for the golfers were instead distributed to the Maison Mère-

Mallet which provides accommodation and meals to those in need in the Québec City area. This gesture brought some happiness to vulnerable people who are deeply affected by the devastating effects of the pandemic.



SIFA FESTIVAL

On June 2nd this year, Portage participated in the first edition of the Social Impact Film and Arts Festival. As part of their music lessons, youth from the Lac Écho program composed and recorded a song entitled Something New, which describes how therapy impacts their recovery. An accompanying video was featured at the festival.

In addition, under the supervision of their arts teacher, the residents of the program for women suffering from mental illness and chemical abuse (MICA) created three paintings representing their therapeutic journeys before, during, and after Portage. Their works were on exhibit at the festival.

As well as being a great source of motivation for our artistic residents, the SIFA festival provided an ideal opportunity to raise awareness around Portage's mission.

FREEDOM FROM ADDICTION GOLF CLASSIC

The first ever golf tournament held by Portage Ontario was held on July 15, 2021. Despite a heavy rain forecast, the weather held up to allow 87 golfers to play in support of Portage. The event raised \$30,000 to support programs at the Elora adolescent treatment centre.



CODY SHEPPERD MEMORIAL GOLF TOURNAMENT

The Cody Shepperd Memorial Golf Tournament, held on September 12, 2021 at the WildWinds Golf Club raised \$17,850 for Portage Ontario. Held in memory of a young man who lost his life to mental health issues and addiction, the Wellington based event donates funds to causes that serve vulnerable youth in the region.



PEDAL FOR PORTAGE 2021

This year's annual Pedal for Portage event was conducted virtually from September 14 to September 20, raising \$36,828. In previous years, the event drew cyclists from all over the province to scenic Centre Wellington in support of Portage Ontario. It also helped to shed light on the realities of substance abuse among youth and to raise community awareness of the stigma attached to addiction. Over the past four years, the event has raised over \$250,000 for the Elora centre.



RECOGNITION DAY 2021

On October 2, Portage Ontario held its annual Recognition Day celebrating the achievements of youth and families overcoming addiction. This year, the ceremony recognized 28 youth for successfully completing not just their residential rehabilitation phase, but practicing a healthy lifestyle for a year. In addition, a mother shared her journey about supporting her son through his struggle. With a husband who is a lawyer, two other sons who are engineers and herself a retired school teacher, this parent epitomizes the *saying* addiction can happen to anyone; rich or poor.


